

F1 Sponsor Form

International Students who are admitted into a degree program at Woodbury University must obtain a Certificate of Eligibility (Form I-20) to enable them to obtain an F-1 Student Visa to enter and/or remain in the U.S. in legal F-1 student status. This requirement applies both to international students who are coming from abroad and F-1 students who are transferring from another U.S. institution.

For Woodbury University to issue you a Form I-20 you must submit the following:

- 1. This form with Section One and Section Two both completed, including signatures from both you (the student) and your sponsor(s).
- 2. A copy of your Passport name page and/or Visa picture page, if you are in the United States
- **3. Original** bank statement(s), on bank letterhead, from you or your sponsor, issued no earlier than <u>6 months</u> of the date you intend to begin your studies. Account balance(s) must be shown in an amount greater than or equal to the amounts listed in Section Two. **Note**: Bank statements must be for a checking, savings, or time deposit account. Brokerage (stock funds), real estate, or any other non-liquid assets are not acceptable. *All bank statements must be in English and in U.S. dollar currency or its foreign equivalence.*
- **4**. If dependents will be accompanied, please provide a copy of each dependents passport (name) page, marriage certificate for you and your spouse in English and birth certificates for children in English.
