  - c. Scores from the California High School Proficiency Examination (CHSPE) cannot be accepted in lieu of a high school GPA, but passing the CHSPE does meet the high school graduation requirement of the Entitlement Cal Grant program. Also, transcripts, and other proficiency certificates WILL NOT BE ACCEPTED. Only scores from the SAT reasoning test WILL BE ACCEPTED. Subject test scores will NOT BE PROCESSED.
- 8. March 2 Deadline missed Late GPA Appeal: High School graduates in the year 2022 or 2023, or students transferring from a CA Community College to a four-year university can submit this form by May 16 explaining the reason why the GPA was submitted late. Cal Grant C and Competitive students must submit this form by March 22 explaining the reason why the GPA was submitted late.
- 9. **September 2 Deadline Late GPA Appeal missed:** CA Community College students can submit this form by September 22 explaining the reason why the GPA was submitted late.
- 10. Student signature: By signing this form, you certify that you have read these instructions and that the information you have provided is correct. It is illegal to report false or misleading information on this form and doing so may result in any Cal Grant award being revoked.
