I-20 Sponsor Form 2025-2026

International Students who are admitted into a degree program at Woodbury University must obtain a Certificate of Eligibility (Form I-20) to enable them to obtain an F-1 Student Visa to enter and/or remain in the U.S. in legal F-1 student status.
